The Ranch offers residents on-site recreational activities and boasts homesites ranging from quarter-acre villas, one to ten-plus acre estates, valley-view, golf course, Guadalupe River frontage, and hilltop home sites. The Clubs of Cordillera Ranch features seven resort-style clubs in one location: The Golf Club, The Social Club, The Tennis and Swim Club, The Equestrian Club, The Rod and Gun Club, The Spa and Athletic Club, and The River Club.

Club dining is at the core of every social experience at TCCR. The Club considers its Food and Beverage amenity equal in importance to its other amenities. It plays a significant role in achieving its Club Mission. As part of this initiative, it seeks to achieve Favorite Place Status in the eyes of its members. Achieving Favorite Place Status does not mean the Club must be every member's most favorite place to dine; it does require the Club to be on every member's list of their top two to three eateries they favor and frequent most when they dine away from home. All members have a choice when choosing a place to dine and entertain. TCCR desires their "Restaurant at the Ranch" become a dining destination equal to the best eateries in the Boerne area.

While the Club was built and opened in 2006, it is poised to begin a multi-million-dollar

renovation to the 5,000 sq. ft. poolside Cabana as well as the Main Kitchen.

The Club is seeking a Director of Food & Beverage/Clubhouse Manager (DFB/CM). This Department Head position fills the number one leadership role in all F&B at the Club and this person will work closely with other Department Heads to fulfill the Club's mission and serve in a leadership role for Clubhouse operations.

Position Role and Responsibilities

The DFB/CM will report to the General Manager and work as a peer with the Executive Chef and Director of Facilities to first in importance oversee the quality, consistency, and hospitality delivered of the Club's Food & Beverage offerings, and second, the housekeeping and maintenance of the Club's member inhabited buildings. For this person to be most successful in this role they must approach this position as being the *Chief Hospitality Officer* for The Clubs of Cordillera Ranch. This role is responsible for the hiring, orientation, onboarding, continuous training, professional development, mentoring, communicating, measuring success, and disciplining of all F&B employees who touch the members of Cordillera Ranch throughout the Club property. Their direct reports are:

- Bar Manager
- Wine Specialist
- Pool Manager

The DFB/CM must possess and exhibit a charismatic, coach training, "heart of a teacher" leadership style. They must be proficient in dining service leadership and establish standards and service procedures, setting goals and systems for measuring success.
