# **POSITION SUMMARY:**

The Director of Golf manages the Golf Division for the Club and must be a proficient low handicap or scratch player with the experience and ability to lead member instruction, play, and coaching. The ideal candidate will have a competitive collegiate and professional playing history background.

Ideal Candidates must have a demonstrated history of leading operations that deliver quality in operational service standards on a day-to-day basis in each business segment. The Director of Golf must be structured and organized to implement defined goals and initiatives to achieve the mission, vision, and brand of being an unparalleled Club and Community.

The Director of Golf has full operational ownership of all golf tournament events, from creation, marketing, organization, and implementation. After each event, a tournament recap summary will be presented to the General Manager / COO and Golf Committee.

The Director of Golf reports directly to the General Manager / COO of the Vaquero Club for all direction, operations, financial, and strategic planning.

#### JOB SUMMARY:

Manages all golf and golf-related activities and business. Responsible for all golf activities, membership instruction, and course play. Plans promote and direct all golf operations staffing. Is highly visible, charismatic, with high integrity and leadership skills.

#### **INTERACTION:**

Frequent interaction with the membership and their guests, vendors, and employees. The Director of Golf must exhibit a coach training leadership/management style when interacting with all Vaquero employees.

# **ESSENTIAL FUNCTION:**

- Prepares annual and monthly budgets for assigned business operations; takes corrective actions as necessary to help assure that all budget / financial goals are attained.
- Oversees the ordering of all retail merchandise. Organizes and displays all retail of the highest quality that the general membership will support. Develops a "member special-order process" via web-based or phone for all retail merchandise.
- Orders all supplies associated with golf, retail and tournament, and training activities.
- Selects, supervises, trains, and evaluates all golf staff.
- Will be available to provide golf lessons to members and guests.
- Plays golf with members of all skill levels to generate enthusiasm.
- Designs and conducts golf clinics that promote membership education and consistent play.
- Plans professional development and training activities for subordinates to ensure that assistants finish all PGA training. Implements a Golf Operations "Playbook" or business plan and manual.
- Designs and conducts junior golf clinics and youth training/entertainment programming.
- Collects all related fees as detailed to the membership and the financial plan.
- Organizes and conducts club tournaments and related competitive events and play days such as Men's Golf, Ladies' Golf, Couples' Golf, Youth / Junior golf development, 9-hole Playgroups/leagues, etc....
- Enforces the USGA golf rules and regulations and local rules as reviewed with and approved by the General Manager / COO and Golf Committee.
- Enforces club policies, rules, and regulations (as assigned or approved by the General Manager / COO).
- Consults with the General Manager / COO about golf course practice range operations, training, maintenance, and golf operations every week.
- Cooperates, partners, and coordinates with the Golf Course Superintendent on all golf maintenance issues that affect the playability of the golf course and practice facilities.
- Implements and administrates a system governing the start of play and maintains USGA recorded handicaps for all members.
- Represents the Club in all area PGA professional events, including local, state, or national events, with the approval of the General Manager / COO.
- Attends all weekly senior management and operations meetings (as assigned).
- Maintains records, key statistics relating to the player and guest rounds, revenues, and other usage metrics (as assigned by the General Manager / COO).
- Provides course marshals for tournaments and at other times as required to maintain the established "pace of play" for the golf course. Supervises all course marshals to help ensure the pace of play is maintained on the course for the benefit of all players.
- Responsible for maintaining and managing all maintenance to the golf carts and or beverage carts used on the golf course (through the golf cart vendor fleet services).
- Adheres to all Federal, State, and Local laws regarding health, safety, and employment.

- Schedules staff hours to assure that members are fully served and followed up within 24 hours as a priority and that labor costs are maintained (periodically check(s) timecards for adherence to posted schedules).
- Assists in developing short and long-range plans to improve club facilities and retail operations.
- Attends PGA national and sectional conferences/meetings, merchandise shows, educational and professional shows to encourage development and to enhance quality and image of the club as budgeted and approved by the General Manager / COO.
- Assists supervising and inspecting design improvements and capital outlays to golf courses and golf facilities with the golf course superintendent.
- Performs all work-related duties as assigned by General Manager COO.

# **SPECIAL REQUIREMENTS:**

- Ability to keep the information confidential at all times.
- Must possess an outgoing charismatic personality at all times.
- Must possess honesty and integrity at all times.
- Must be courteous and tactful at all times.
- Must treat others with kindness and respect.

- Must adhere to the PGA Code of Ethics and Regulations and present oneself in a firstclass, professional manner at all times. The Director of Golf will also adhere to the Vaquero Club Senior Management Uniform Standards (as defined by the General Manager / COO for all Divisional Managers).
- Must implement and practice the Vaquero Club CORE values with a "coach training leadership style" when managing all Vaquero Club employees.
- Manages all marketing and communication for the Golf Operations division and assigned business segments to the membership via club newsletter, email blast, videos, and website content as approved by the General Manager / COO.
- The responsible leader for implementing extensive Golf Tournaments and Club Programming (for all assigned business segments) to include an annual golf activity calendar for the membership.
- Establish an intern program with the PGA and related Golf Schools across the Country for the Vaquero Club. The ideal candidate must be known for developing Assistant Golf Professionals into Class A PGA Directors of Golf at other private clubs. The Club desires to be known for developing high-quality leaders for other Club opportunities.
